Approval of July 26th ,2023 Special Board meeting minutes – Dave P moved to accept July 26th minutes, Jeneé Pearce-Mushen seconded and all approved.

Treasurer's Report – The treasure's report was read and written by Bill Cote. Highlights are summarized below in Bill's Report.

Questions were asked about the US Bank loan and if we should pay it off, Chief will get answers that are a little clearer for everyone, and we can decide if we should go ahead and pay that off. There are penalties if paid off early. This was looked at one year ago and at the time it was not in our best interest to pay for that. We will revisit this and see If it would be better to pay off at this time.

Call Response

The Chief, Jason and Karen would be putting everything in the files for the board to see. Dave P asked if this is a policy, the chief stated it is not a policy yet, but it could be. No one is thinking they need this to be a policy. This would be coming out of our communications budget which we have money for. Everyone is thinking this would be a good thing, The Chief is going to have this ready for everyone for the next board meeting on Sept. 11th, 2023. We are going paperless!

Reports -

- Chief Report The Chief was not able to send this out in an email since he was away. He has a short report. Update on projects. Jason and the Chief will be going to the city council meeting tomorrow to go over the roads and how they cannot reach fires without them being cleared.
- Staffing we are hoping to be finished by mid Aug. We are offering it to 5 different people, they are going through the background etc. We are hoping to get even more part-time staff after the 5 starts.
- Fire Marshal we ended up with 7 applications, we will prob invite 3 back for assessment center. The Chief has lined up a house for our new Fire Marshal, the fire district will be leasing the house. Target start date is Jan1, 2024

Division Chief Report – Training was slow this month, the first meeting was canceled because it was followed by July 4th. Everyone was exhausted.
 This month surf rescue training was done along with the lifeguard being involved. This went very well. Great response and everything done in 11 min. 2nd drill night was rope rescue, this went well also.

Matt Thornhill just completed his EMT.

Shaunna and Levi also have gone through advanced EMT training they have the written part left of testing and then we will have 2 more Advanced EMT's.

Lifeguards have been super busy. We have had 3 on the beach would like 4. One day we had only 2. Last Saturday we had 5 on the beach. Things are going great. Next year we could be in a bad spot due to losing 3 or 4 lifeguards. We will need to be working on our lifeguard program moving forward.
